Once home to a beautiful equestrian ranch, situated along the historic Route 66 Highway. Farm & ranch fell into disrepair and sat idle for many years...including the last remaining, iconic Meramec Caverns barn.

Working with the Route 66 Preservation Society, the ranch and iconic barn are being restored to their former glory and turning Meramec Caverns Ranch into a Nexus for hemp genetics, research and cultivation.


